Portfolio Summary

RE: NCCF - Global Growth

As of August 31, 2026, the portfolio was valued at \$128,067,729, versus \$127,181,890 on June 30, 2026. Returns for the current quarter-to-date were 1.49%, compared to the Index Composite of 1.67%. Net cash flows for the quarter-to-date were (\$995,058) while the portfolio total return was \$1,880,897.

One-year portfolio returns were 16.42%, compared to 18.70% for the Index Composite.

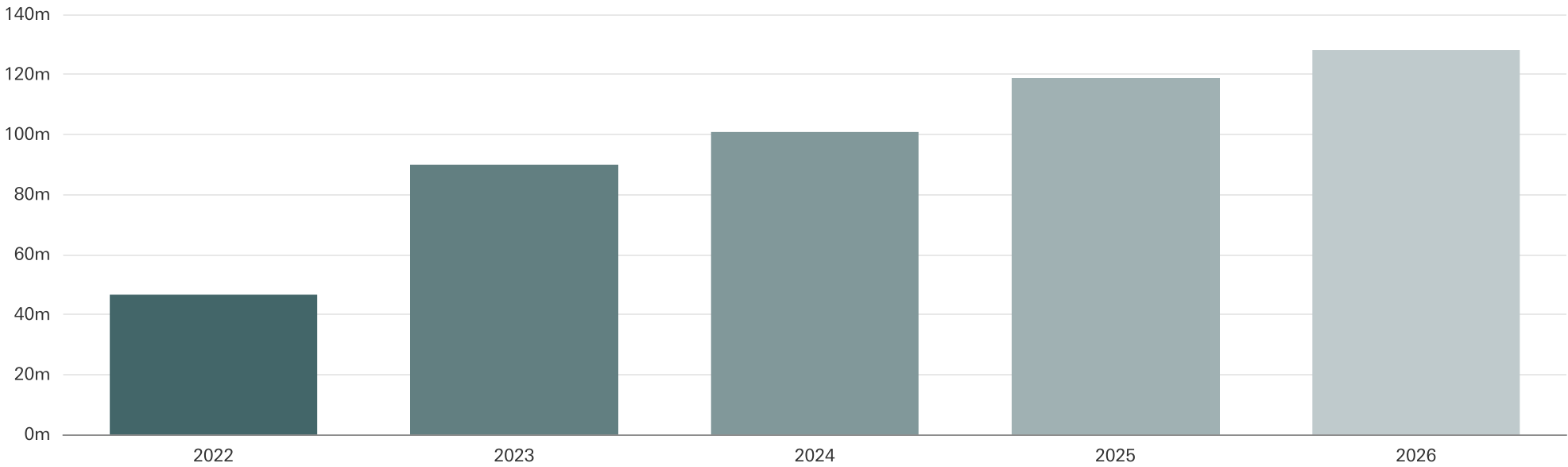

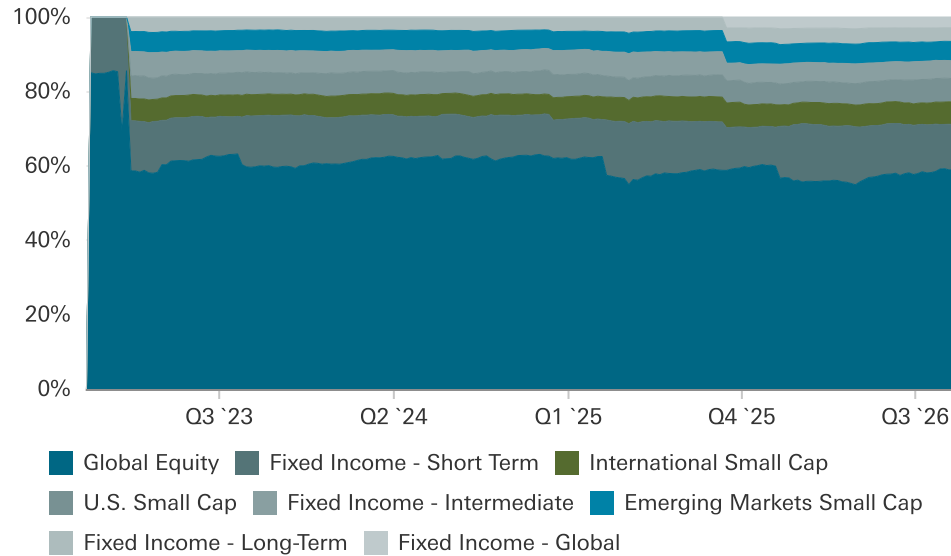

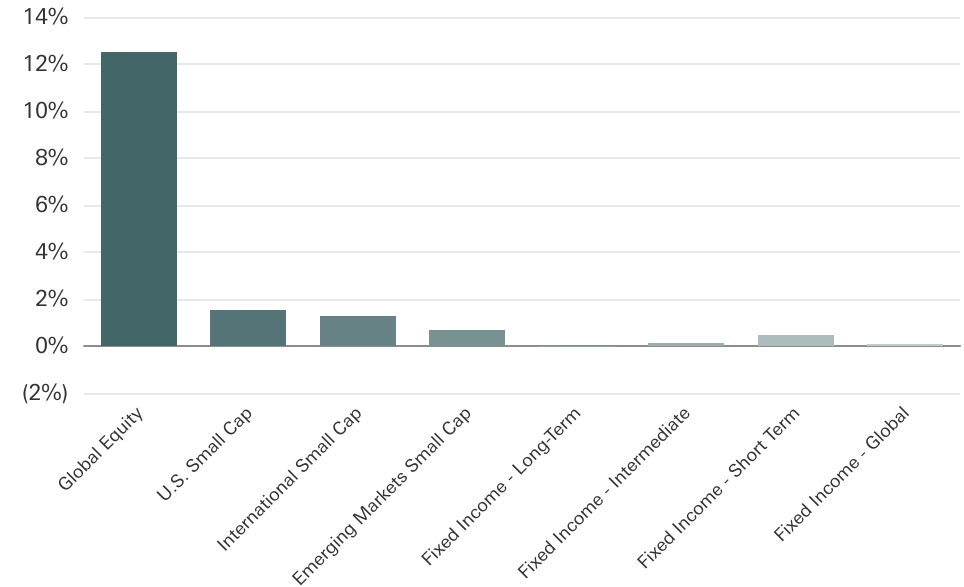
Portfolio Value over Time

Contributions by Sector (1Yr.)

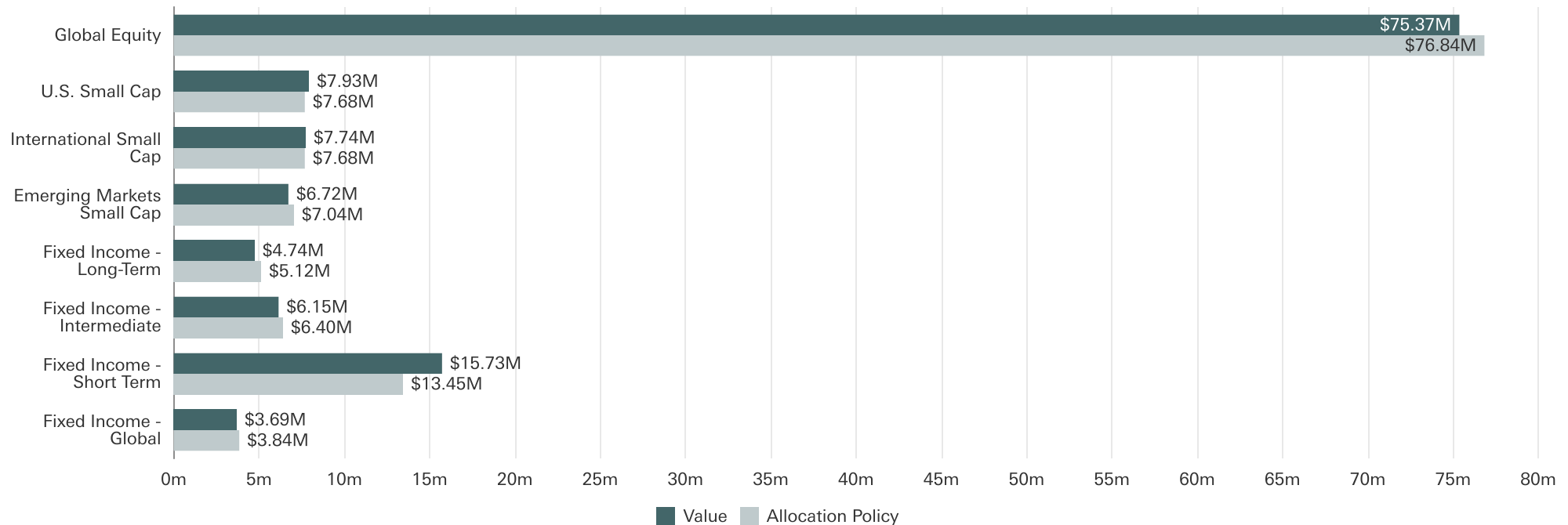
